

Magic 106.7 / Jim Brickman: “A Christmas Special” Contest Rules

How to Enter for a Chance to Win

MAGIC 106.7’s “Jim Brickman: A Christmas Special” contest will run from November 28, 2011 – December 2, 2011.

To participate, listen to “Bedtime MAGIC” each weeknight on MAGIC 106.7 at around 9:35pm. When we play a song from Jim Brickman at that time, be caller # 10 at 617-931-1067 to win tickets to see Jim Brickman at The Wilbur Theatre in Boston on December 4, 2011.

NOTE: Only a song performed by Jim Brickman, when played in its entirety from beginning to end, will be used to solicit contest calls. Snippets of songs played for advertising or promotional purposes and music beds that contain music from a Jim Brickman song WILL NOT count. Listeners should try to be the 10th caller at 617-931-1067 as soon as they hear a Jim Brickman song begin to play at approximately 9:35pm. If a listener accidentally calls when a song snippet or music bed is played, s/he will simply be informed of the error.

Winner qualification is subject to FULL phone call completion, and the verification of the caller’s name, address, home phone number, work/cell phone number and social security number, all of which must be provided prior to completion of the call. Contest calls will not be accepted at any other number.

Online listeners to the Magic 106.7 (Station) web stream may experience a reception delay of up to one minute. Listening to the station’s over-the-air broadcast is the best way to participate in this contest.

Prizes & Restrictions

Five (5) prizes will be awarded, each a pair of tickets to the Jim Brickman concert at The Wilbur Theatre in Boston, MA on December 4, 2011. ARV: \$110 Tickets will be awarded as follows:

- 5th Row tickets on Monday, November 28th
- 4th Row tickets on Tuesday, November 29th
- 3rd Row tickets on Wednesday, November 30th.
- 2nd Row tickets on Thursday, December 1st.
- Front Row tickets on Friday, December 2nd..

Odds of winning depend in part on number of people trying to call in. Non-cash prizes are not redeemable for cash.
