

KEEP TRACK OF THE MUSIC / MAGIC 106.7 Contest Rules

NO PURCHASE OR OTHER CONSIDERATION IS NECESSARY TO PARTICIPATE IN THIS CONTEST; PURCHASE DOES NOT INCREASE CHANCES OF WINNING.

How to Enter for a Chance to Win

Listen to Magic 106.7 on weekends. When instructed by the on-air announcer, start keeping track of the songs played during the specified hour. At the end of the hour, the on-air announcer will invite listeners to call in and name the last song played by a certain artist during the “Keep Track” hour. Be caller #10 at 617-931-1067 (or #1067 from a Verizon Wireless phone), and if you correctly identify the song, you will win the prize. If caller #10 does not correctly identify the song, Magic will continue to take callers until the song is identified. Winner qualification is subject to FULL phone call completion, and the verification of the caller’s name, address, home phone number, work/cell phone number and social security number, all of which must be provided prior to completion of the call. Contest calls will not be accepted at any other number.

Magic 106.7 will announce the beginning of a “Keep Track of the Music” hour at approximately the following times:

Saturday at 8:15, 10:15, 12:15, 2:15, 4:15 and 6:15.

Sunday at 12:15, 2:15, 4:15 and 6:15.

The Station will invite listeners to call in at approximately the following times:

Saturday at 9:15, 11:15, 1:15, 3:15, 5:15 and 7:15.

Sunday at 1:15, 3:15, 5:15 and 7:15.

For Holiday weekends (currently scheduled for Memorial Day, July Fourth, and Labor Day), Monday will follow Saturday’s schedule.

Online listeners to the Station web stream may experience a reception delay of up to one minute. Listening to the station’s over-the-air broadcast is the best way to participate in this contest.

Prize

Up to ten (10) prizes will be awarded each weekend (up to 16 for a holiday weekend), until Station discontinues the Keep Track of the Music contest.

Prizes change every week. Listen to Magic 106.7 or visit our website at www.magic1067.com for the current week’s prizes.

Odds of winning depend on number of phone calls received. Non-cash prizes are not redeemable for cash. MAGIC 106.7 reserves the right, in its sole discretion, to substitute any prize with one of equal or greater value. Winners may not request prize substitution. Prizes are non-transferable and may not be claimed or used by any person other than the winner. Winners must claim their prizes in person at the MAGIC 106.7 offices within 30 days after the end of the contest or as otherwise instructed by Station promotions staff. Prizes not claimed within the 30-day period or as otherwise instructed will be forfeited.

Eligibility

All entrants must be at least 18 years old and legal residents of the United States, living or working in Station’s total survey area (as defined by Arbitron). A winner will be disqualified if he/she or a member of his/her household has won a MAGIC 106.7 contest with a value over \$50.00 within the previous 60 days, or a value of \$1000 or greater within the previous 365 days.
